# NOTE ON THE INDUCED METRIC ON POWER SETS OF GROUPS

ABSTRACT. In this note we clarify general properties of the Hausdorff-like metric on the power sets  $\mathcal{S}(G)$  of a group G induced from word length norm and obtain some results on quasi-isometries between some subspaces of  $\mathcal{S}(G)$  and  $\mathcal{S}(H)$  for a group epimorphism  $f: G \to H$ , when  $\mathcal{S}(\operatorname{Ker} f)$  is metrically bounded.

#### 1. Introduction

The study of boundedness of groups aims a quantitative understanding of various norms and metrics on groups or some spaces associated to them (cf. [1, 2, 6, 8, 9, 10, 11], etc). In [6, 7] J. Kędra, A. Libman and B. Martin studied strong and uniform boundedness of finitely normally generated groups based on the word lengths  $|| ||_S$  with respect to finite normally generating sets S on a group. For a study of unbounded groups, in [8] they consider coarse type of Tsuboi metric spaces associated to relatively simple groups and also after [6, 7] Morimichi Kawasaki have studied the metric on the set of finite normally generating sets of a finitely normally generated group modulo symmetrization and conjugation, obtained by symmetrizing the word length norm in [6, 7].

Our goal in this subject is a complehensive study of boundedness of bundle diffeomorphism groups and diffeomorphism groups of manifold pairs. In [4, 5] we have studied the cases of bundle diffeomorphism groups over a circle and diffeomorphism groups of manifold pairs, in which the submanifold is a finite disjoint union of circles, and are in preparation of successive papers in the higher dimensional cases. As a preliminary of these works, in this note we try to make a framework and a foundation under a general setting and clarify general properties on the extended metric on the power set  $\mathcal{S}(G)$  of a group G, which is induced from the word lengths with respect to subsets of G. Here, the power set  $\mathcal{S}(G)$  is the set of all subsets of G and we treat the wide class of extended (additive/multiplicative) assymmetric metrics with values in  $\mathbb{R}_{\geq 0} \cup \{\infty\}$ . Each  $S \in \mathcal{S}(G)$  induces the word length  $\nu_S$  on G and its Hausdorff version  $(\nu_S)_H$  on  $\mathcal{S}(G)$ , from which obtained are the multiplicative/additive assymmetric metrics  $\nu(S,T) = (\nu_S)_H(T)$  and  $\varrho(S,T) = \log \nu_H(S,T)$  (cf. [6, Section 2]). The usual symmetric metrics  $\widehat{\nu}$  and  $\widehat{\varrho}$  are readily obtained by symmetrizing  $\nu$  and  $\varrho$ . We list formal properties of these extended metrics. In this general setting,

one of main problems is to understand relations as metric spaces among (some subspaces of) the power sets S(G), S(H) and S(K) for a group epimorphism  $f: G \to H$  with K = Ker f. We obtain some weak results on quasi-isometries between some subspaces of S(G) and S(H) when S(K) is metrically bounded.

Although the materials in this note are seemed to be essentially known for the authors in [6, 7], we expect that it is useful for our works to clarify general properties of the metrics in  $\mathcal{S}(G)$  in this general setting. As an advantage of this framework we can treat various subsets of a group simultaneously within the ambient extended metric space. We also extend this framework to the cases of group actions and sets with binary operations.

### 2. Baiscs on asymmetric metrics and Hausdorff metrics

This section is devoted to generalities on asymmetric metrics and Hausdorff metrics on powersets.

### 2.1. Asymmetric metrics.

Let X be a set.

**Definition 2.1.** For a function  $d: X \times X \longrightarrow \mathbb{R}_{>0} \cup \{\infty\}$  consider the following conditions:

(ii) 
$$d(x,y) = d(y,x) \quad (\forall x, y \in X)$$

(iii) 
$$d(x,z) \le d(x,y) + d(y,z) \quad (\forall x,y,z \in X)$$

We say that the function d is

- 1) an asymmetric metric on X if d satisfies (i) and (iii),
- 2) nondegenerate if it satisfies (i)',
- 3) a psuedo metric on X if it satisfies (i), (ii) and (iii),
- 4) a metric on X if it satisfies (i)', (ii) and (iii).

**Definition 2.2.** For a function  $\varrho: X \times X \longrightarrow \mathbb{R}_{\geq 1} \cup \{\infty\}$  consider the following conditions:

$$\text{(i)} \quad \varrho(x,x) = 1 \quad (\forall x \in X) \\ \text{(i)'} \quad \left[ \, \varrho(x,y) = \varrho(y,x) = 1 \, \iff \, x = y \, \right] \quad (\forall x,y \in X)$$

- (ii)  $\varrho(x,y) = \varrho(y,x) \quad (\forall x,y \in X)$
- (iii)  $\varrho(x,z) \le \varrho(x,y) \cdot \varrho(y,z) \quad (\forall x,y,z \in X)$

We say that the function  $\rho$  is

- 1) a multiplicative asymmetric metric on X if d satisfies (i) and (iii),
- 2) nondegenerate if it satisfies (i)',
- 3) a multiplicative psuedo metric on X if it satisfies (i), (ii) and (iii),
- 4) a multiplicative metric on X if it satisfies (i)', (ii) and (iii).

Briefly, "an asymmetric metric" is abbreviated as "an as metric".

For notational simplicity we use the following notations. For any subset  $J \subset \mathbb{R}$  and  $r \in \mathbb{R}$  we set  $J_{\geq r} := \{x \in J \mid x \geq r\}$  and  $\widetilde{J}_{\geq r} := J_{\geq r} \cup \{\infty\}$ . For sets X and Y the symbol F(X,Y) denotes the set of functions from X to Y. For  $f \in F(X, \widetilde{J}_{\geq r})$  we write  $f < \infty$  if f takes its values in  $J_{\geq r}$ .

Notation 2.1. The notations  $\mathcal{M}(X;J)$ ,  $\mathcal{M}_p(X;J)$  and  $\mathcal{M}_{as}(X;J)$  denote the sets of metrics, psuedo metrics and as metrics on a set X with values in  $J \subset \mathbb{R}_{\geq 0}$ , respectively. Similarly,  $\mathcal{M}_m(X;I)$ ,  $\mathcal{M}_{m,p}(X;I)$  and  $\mathcal{M}_{m,as}(X;I)$  denote the sets of multiplicative metrics, psuedo metrics and as metrics a set X with

values in  $J \subset \widetilde{\mathbb{R}}_{\geq 1}$ , respectively. The symbols J and I are omitted when  $J = \widetilde{\mathbb{R}}_{\geq 0}$  and  $I = \widetilde{\mathbb{R}}_{\geq 1}$ . For  $d \in \mathcal{M}_{as}(X)$  its restriction to  $A \subset X$ ,  $d|_{A \times A} \in \mathcal{M}_{as}(A)$ , is simply denoted by  $d|_A$ .

In this note we work in the set  $\mathcal{M}_{as}(X)$ . Since  $d \in \mathcal{M}_{as}(X)$  may be degenerate or non-symmetric and may take the value  $\infty$ , we list so basic properties in order to remind and confirm them, while their proofs are omitted since those follows directly form their definitions and routine arguments.

**Notation 2.2.** Let  $d \in F(X^2, \widetilde{\mathbb{R}}_{>0})$ . The symmetrization of d is defined by

$$\widehat{d}: X \times X \longrightarrow \widetilde{\mathbb{R}}_{>0}: \widehat{d}(x,y) = \max\{d(x,y), d(y,x)\}.$$

If  $d \in \mathcal{M}_{as}(X)$ , then (i)  $\widehat{d} \in \mathcal{M}_p(X)$  and (ii)  $\widehat{d} \in \mathcal{M}(X)$  if and only if d is nondegenerate.

We recall some notions on (quasi-)isometries.

**Notation 2.3.** Suppose  $f:(X,d)\to (Y,\varrho)$  is a map between (additive/multiplicative) as metric spaces. We use the following terminologies.

- (1) (i) f is isometric if  $\varrho(f(x), f(x')) = d(x, x') \ (\forall x, x' \in X)$ . If f is isometric and d is nondegenerate, then f is injective.
  - (ii) f is an isometry if f is an isometric bijection.
- (2) f is a quasi-isometric map, if it satisfies the following condition:
  - $(\dagger) \quad \varrho(f(x), f(x')) \le \lambda d(x, x') + C \quad (\forall x, x' \in X) \quad \text{for some } \lambda \in \mathbb{R}_{>1} \text{ and } C \in \mathbb{R}_{>0}.$
  - $\circ$  When d and  $\varrho$  are multiplicative as metrics, the condition (†) is replaced as follows:
    - $(\ddagger) \ \varrho(f(x), f(x')) \le Dd(x, x')^{\lambda} \ (\forall x, x' \in X) \quad \text{for some } \lambda \in \mathbb{R}_{\ge 1} \text{ and } D \in \mathbb{R}_{\ge 1}.$
- (3) Let  $r \in \mathbb{R}_{\geq 0}$ . Two maps  $h, h' : X \to (Y, \varrho)$  are r-close if  $\widehat{\varrho}(h(x), h'(x)) \leq r \ (\forall x \in X)$ .
- (4) f is a quasi-isometry if f is a quasi-isometric map and there exists a quasi-isometric map  $g:(Y,\varrho)\to (X,d)$  such that gf is r-close to  $\mathrm{id}_X$  and fg is r-close to  $\mathrm{id}_Y$  for some  $r\in\mathbb{R}_{\geq 0}$ .

Notation 2.4. Let W be a set and  $f, g \in F(W, \widetilde{\mathbb{R}}_{\geq 0})$ .

- (1)  $f \leq_q g \iff f \leq \lambda g + C$  for some  $\lambda \in \mathbb{R}_{\geq 1}$  and  $C \in \mathbb{R}_{\geq 0}$ ).
- (2)  $f \sim_q g$  (quasi-equivalent)  $\iff f \leq_q g$  and  $g \leq_q f$

Note that for  $d, d' \in \mathcal{M}(X)$ ,  $d \sim_q d'$  if and only if  $\mathrm{id}_X : (X, d) \longrightarrow (X, d')$  is a quasi-isometry. We can introduce a natural metric to the set  $\mathcal{M}_{as}(X) \subset F(X^2, \widetilde{\mathbb{R}}_{\geq 0})$ .

Notation 2.5. Let W be any set.

(1) The set  $F(W, \mathbb{R}_{>0})$  has the following nondegenerate as metric

$$\mu(f, f') := \begin{cases} \inf\{r \in \mathbb{R}_{\geq 0} \mid f' \leq f + r\} & (\exists r \in \mathbb{R}_{\geq 0} \text{ s.t. } f' \leq f + r) \\ \infty & (\text{otherwise}) \end{cases}$$

(2) The multiplicative version of  $\mu$  is defined by

$$\lambda: F(W, \widetilde{\mathbb{R}}_{\geq 1})^2 \longrightarrow \widetilde{\mathbb{R}}_{\geq 1}: \ \lambda(g, g') := \left\{ \begin{array}{ll} \inf\{s \in \mathbb{R}_{\geq 1} \mid g' \leq sg\} & (^\exists s \in \mathbb{R}_{\geq 1} \text{ s.t. } g' \leq sg) \\ \infty & (\text{otherwise}) \end{array} \right.$$

(3) The additive as metric  $\mu$  and the multiplicative as metric  $\lambda$  correspond under the reciprocal bijections :

$$\exp_*: F(W, \widetilde{\mathbb{R}}_{\geq 0}) \longrightarrow F(W, \widetilde{\mathbb{R}}_{\geq 1}) \qquad \log_*: F(W, \widetilde{\mathbb{R}}_{\geq 1}) \longrightarrow F(W, \widetilde{\mathbb{R}}_{\geq 0})$$

$$f \qquad \exp f \qquad g \qquad \log g$$

- (i)  $\mu = \log \lambda \left( \exp_* \times \exp_* \right)$
- (ii) For  $f, f' \in F(W, \mathbb{R}_{>0})$  and  $r \in \mathbb{R}_{>0}$  $\mu(f, f') < r \iff f' < f + r \iff e^{f'} < e^r e^f \iff \lambda(e^f, e^{f'}) < e^r$

**Definition 2.3.** The set  $\mathcal{M}_{as}(X)$  inherits the nondegenerate as metric  $\mu|_{\mathcal{M}_{as}(X)}$  from  $(F(X^2, \mathbb{R}_{\geq 0}), \mu)$ .

(i) 
$$\mu(d, d') \le r \iff d' \le d + r \quad (d, d' \in \mathcal{M}_{as}(X), r \in \mathbb{R}_{\ge 0})$$

**Notation 2.6.** Suppose (X, d),  $(Y, \varrho)$  are as metric spaces.

(1) We have an as metric  $\mu \in \mathcal{M}_{as}(X \times Y) : \mu((x,y),(x',y')) = \max\{d(x,x'),\varrho(y,y')\}.$ If d and  $\varrho$  are nondegenerate, then  $\mu$  is also nondegenerate.

### 2.2. Hausdorff metrics on the power sets.

Next we recall basic notions on Hausdorff metrics. Let X be a set. The symbol  $\mathcal{S}(X)$  denote the power set of X, that is, the set of all subsets of X. We also set  $\mathcal{S}_f(X) := \{S \in \mathcal{S}(X) \mid |S| < \infty\}$ . We regard as  $X \subset \mathcal{S}(X)$  by identifying each point  $x \in X$  with the singleton  $\{x\} \in \mathcal{S}(X)$ . Each  $d \in \mathcal{M}_{as}(X)$  determines the Hausdorff metric  $d_H \in \mathcal{M}_{as}(\mathcal{S}(X))$ . The r balls and r neighborhoods with respect to d are denoted by the following notations.

**Notation 2.7.** Let  $d \in \mathcal{M}_{as}(X)$ ,  $x \in X$  and  $A \subset X$ .

(1) 
$$B_d(x,r) := \{ y \in X \mid d(x,y) \le r \}$$
  $B_d(A,r) := \bigcup_{a \in A} B_d(a,r)$   $(r \in \mathbb{R}_{\ge 0})$ 

$$(2) B_d(x,\infty) := \bigcup_{r \in \mathbb{R}_{>0}} B_d(x,r) \qquad B_d(A,\infty) := \bigcup_{a \in A} B_d(a,\infty) = \bigcup_{r \in \mathbb{R}_{>0}} B_d(A,r)$$

We omit the symbol d when it is understood from the context.

### Fact 2.1.

$$(1) \ x \in B(x,0), \ A \subset B(A,0) \qquad (2) \ A \subset A' \implies B(A,r) \subset B(A',r) \quad (r \in \widetilde{\mathbb{R}}_{\geq 0})$$

(3) 
$$B(B(A,r),s) \subset B(A,r+s) \quad (r,s \in \widetilde{\mathbb{R}}_{>0})$$

**Definition 2.4.** Each  $d \in \mathcal{M}_{as}(X)$  induces an as metric  $d_H \in \mathcal{M}_{as}(\mathcal{S}(X))$  defined as follows.

(1) 
$$d_H: \mathcal{S}(X) \times \mathcal{S}(X) \longrightarrow \widetilde{\mathbb{R}}_{\geq 0}:$$

$$d_{H}(A, A') := \begin{cases} \inf\{r \in \mathbb{R}_{\geq 0} \mid A' \subset B_{d}(A, r)\} & (\exists r \in \mathbb{R}_{\geq 0} \text{ s.t. } A' \subset B_{d}(A, r)) \\ \infty & (\text{otherwise}) \end{cases}$$

(2) 
$$B_H(A,r) := \{x \in X \mid d_H(A,x) \le r\}$$
  $B_H(A,\infty) := \bigcup_{r \in \mathbb{R}_{>0}} B_H(A,r)$ 

(3) 
$$A \subset X$$
:  $d$ -closed  $\iff B_H(A,0) = A$   $\mathcal{F} \equiv \mathcal{F}(X,d) := \text{the set of } d\text{-closed subsets of } X$ 

Note that  $B_H(A,r) \subset B_{d_H}(A,r)$ .

Fact 2.2. The function  $d_H \in F(\mathcal{S}(X)^2, \widetilde{\mathbb{R}}_{>0})$  has the following properties. Let  $A, A', A'' \in \mathcal{S}(X)$ .

(1) (i) 
$$A' \subset A'' \implies d_H(A, A') \le d_H(A, A'')$$
 (ii)  $d_H(x, y) = d(x, y)$  ( $\forall x, y \in X$ )

(3) For  $r, s \in \mathbb{R}_{>0}$  the following holds.

(i) 
$$d_H(A, A') \le r \iff A' \subset B(A, s) \quad (\forall s \in \mathbb{R}_{>r})$$

(ii) 
$$B(A,r) \subset B_H(A,r) \subset B(A,s)$$
  $(\forall s \in \mathbb{R}_{>r})$   $B_H(A,\infty) = B(A,\infty)$ 

(iii) 
$$d_H(A, A') \le r \iff d_H(A, a') \le r \quad (\forall a' \in A') \iff A' \subset B_H(A, r)$$

(iv) 
$$d_H(A, B_H(A, r)) \le r$$
 (v)  $B_H(B_H(A, r), s) \subset B_H(A, r + s)$ 

- (2)  $d_H(A, A'') \le d_H(A, A') + d_H(A', A'')$
- (3) (i)  $d_H(A, A') = 0 \iff A' \subset B_H(A, 0) \iff B_H(A', 0) \subset B_H(A, 0)$ 
  - (ii)  $d_H(A, A) = 0$  (iii)  $d_H(A, A') = 0 = d_H(A', A) \iff B_H(A, 0) = B_H(A', 0)$
- (4) (i)  $d_H \in \mathcal{M}_{as}(\mathcal{S}(X))$  and  $\widehat{d_H}$  is a pseudo-metric.
  - (ii)  $d_H|_{\mathcal{F}} \in \mathcal{M}_{as}(\mathcal{F})$  is nondegenerate, so that  $\widehat{d_H}|_{\mathcal{F}} = \widehat{d_H}|_{\mathcal{F}} \in \mathcal{M}(\mathcal{F})$ , where  $\mathcal{F} \equiv \mathcal{F}(X, d)$ .

Fact 2.3. Let  $d, d' \in \mathcal{M}_{as}(X)$ . The symbols  $B, B_H$  and  $B', B'_H$  are determined by d and d' respectively.

- (1) If  $d' \leq \lambda d + C$  for  $\lambda \in \mathbb{R}_{>1}$  and  $C \in \mathbb{R}_{>0}$ , then
  - (i)  $B_H(A,r) \subset B'_H(A,\lambda r + C)$   $(\forall r \in \widetilde{\mathbb{R}}_{\geq 0})$  (ii)  $d'_H \leq \lambda d_H + C$
- $(2) \ (\mathrm{i}) \ d \leq_q d' \implies d_H \leq_q d'_H \qquad (\mathrm{ii}) \ d \sim_q d' \implies d_H \sim_q d'_H \implies \widehat{d}_H \sim_q \widehat{d'}_H$

In the case where  $d \in \mathcal{M}_{as}(X)$  takes discrete values, we do not need to distinguish between B(A, r) and  $B_H(A, r)$ .

Fact 2.4. Suppose J is a discrete subset of  $\mathbb{R}_{\geq 0}$  and  $d \in \mathcal{M}_{as}(X, \widetilde{J})$ . Then, the following holds.

- (1) (i)  $0 \in J$  (if  $X \neq \emptyset$ ), since d(x, x) = 0 for any  $x \in X$ .
  - (ii) For any  $r \in \mathbb{R}_{\geq 0}$  there exists  $\lfloor r \rfloor_J := \max J_{\leq r}$ , since  $J_{\leq r} = \{k \in J \mid k \leq r\}$  is a nonempty finite set of J.

Below, let  $r \in \mathbb{R}_{>0}$  and put  $n := |r|_J$ .

- (2) (i) B(A,r) = B(A,n) (ii)  $d_H(A,A') \le r \iff d_H(A,A') \le n$   $(A' \subset X)$
- (3)  $d_H \in \mathcal{M}_{as}(\mathcal{S}(X), \widetilde{J}): d_H(A, A') := \begin{cases} \min\{k \in J \mid A' \subset B(A, k)\} & (\exists r \in \mathbb{R}_{\geq 0} \text{ s.t. } A' \subset B(A, r)) \\ \infty & (\text{otherwise}) \end{cases}$
- (4) (i)  $B_H(A,r) = B_H(A,n)$  (ii)  $B_H(A,r) = B(A,r)$ 
  - 3. METRIC ON THE POWER SET OF A GROUP INDUCED FROM THE WORD LENGTH
- 3.1. Basics on operations for subsets of a group.

Suppose G is a group and  $e \in G$  is the identity element. Let  $G^{\times} := G - \{e\}$ .

Definition 3.1.

- (1) A norm on G means a function  $\nu: G \to \widetilde{\mathbb{R}}_{>0}$  which satisfies the following conditions:
  - (i)  $\nu(x) = 0 \iff x = e$
  - (ii)  $\nu(x^{-1}) = \nu(x) \quad (\forall x \in G)$
  - (iii)  $\nu(xy) \le \nu(x) + \nu(y) \quad (\forall x, y \in G)$
- (2) A function  $\nu: G \to \widetilde{\mathbb{R}}_{\geq 0}$  is conjugation-invariant if it satisfies the following condition :
  - (iv)  $\nu(axa^{-1}) = \nu(x) \ (\forall x, a \in G)$

**Notation 3.1.** For  $S,T\subset G$  we use the following notations.

- $(1) ST := \{xy \mid x \in S, y \in T\} \subset G$
- (2)  $S^n := \{x_1 \cdots x_n \mid x_i \in S \ (i \in [n])\} \quad (n \in \mathbb{Z}_{\geq 1}) \qquad S^0 := \{e\} \qquad S^{-1} = \{x^{-1} \mid x \in S\}$
- (3)  $S^{\leq n} = \bigcup_{k=0}^n S^k \quad (n \in \mathbb{Z}_{\geq 1})$   $S^{\infty} = \bigcup_{n=0}^{\infty} S^n$
- (4) (the conjugations)
  - $\text{(i)} \quad x^a := a^{-1}xa, \quad ^ax := axa^{-1} \quad (x, a \in G) \qquad \qquad \text{(ii)} \quad S^A := \{x^a \mid x \in S, a \in A\} \quad (A \subset G)$

**Notation 3.2.** For  $S \subset G$  we use the following notations.

- (1) (i)  $\langle S \rangle$ : the subgroup of G generated by S
  - (ii)  $\langle \langle S \rangle \rangle$ : the normal subgroup of G normally generated by S
- (2)  $S^{\pm} := S \cup S^{-1}$  (the symmetrization of S)
- (3) (i)  $C(S) := S^G$  (the conjugation closure of S)
  - (ii)  $C_S := (S^{\pm})^G = (S^G)^{\pm}$  (the symmetrized conjugation closure of S)
- (4) (i) S is symmetric.  $\stackrel{\text{def}}{\Longleftrightarrow} S = S^{-1}$ 
  - (ii) S is conjugation-invariant.  $\stackrel{\text{def}}{\iff} S^a \subset S \ (\forall a \in G) \ \stackrel{\text{equiv}}{\iff} S^a = S \ (\forall a \in G)$

**Notation 3.3.** For subsets of S(G) we use the following notations.

[I] For any condition P on subsets S of G, we set  $S_P(G) := \{S \in S(G) \mid S : P\}$ .

Examples of a condition P:

- (1) (i)  $f: |S| < \infty$  (a finite set) (ii)  $g: S^{\infty} = G$  (iii)  $s: S^{-1} = S$  (symmetric)
- (2) (i)  $c: S^G = S$  (conjugation-invariant)  $\iff S = A^G \ (\exists A \in \mathcal{S}(G))$ 
  - (ii)  $fc: S = A^G \ (\exists A \in \mathcal{S}_f(G))$  (iii)  $s, c := s + c \iff S = C_A \ (\exists A \in \mathcal{S}(G))$
- (3) (i) fg := g + s + f (ii) ng := g + s + c
  - (iii)  $nfg := g + s + fc \iff S^{\infty} = G, \ S = C_A \ (^{\exists}A \in \mathcal{S}_f(G))$
- [II] To avoid the degeneracy of induced metrics on S(G) (cf. Fact 3.3(1)), we need some care on the identity element e. For this reason we introduce the following notations.
  - (1) For  $\mathcal{T} \subset \mathcal{S}(G)$  we set  $\mathcal{T}^* := \mathcal{T} \{\emptyset, \{e\}\}.$

$$S \qquad \log \nu_S \qquad \log d_S$$

 $\circ \zeta$  is anti-isometric with respect to  $\varrho$  and  $\mu$  (i.e.,  $\varrho(S,T) = \mu(\log \nu_T, \log \nu_S)$  ( $\forall S, T \in \mathcal{S}'(G)^*$ ).

Proof.

- (1) Consider the map  $\psi: F(G, \widetilde{\mathbb{Z}}_{\geq 0}) \longrightarrow \mathcal{S}'(G): \psi(f) = f^{-1}(0)$ . Since  $\psi\zeta = \mathrm{id}$  by Fact 3.2 (2)(iii), it follows that  $\zeta$  is injective.

Hence, the map  $(S'(G), \nu_H) \longrightarrow (F(G^{\times}, \widetilde{\mathbb{Z}}_{\geq 1}), \lambda)$  is an anti-isometric injection.

If  $m < \infty$ , then  $x \in T^m \subset (S^{\leq n})^m \subset S^{\leq mn}$ . This implies that  $\nu_S(x) \leq mn = n \nu_T(x)$ .

- $(\Leftarrow)$  For any  $x \in T$  it follows that  $\nu_T(x) \le 1$  and  $\nu_S(x) \le n \nu_T(x) \le n$ , so that  $x \in S^{\le n}$ .
- (3) For any  $S, T \in \mathcal{S}(G)^*$  it follows that

$$\varrho(S,T) \equiv \varrho_S(T) = \log(\nu_S)_H(T) = \log \lambda(\nu_T,\nu_S) = \mu(\log \nu_T, \log \nu_S)$$

$$\widehat{\varrho}(S,T) = \widehat{\mu}(\log \nu_S, \log \nu_T).$$

Here we have some examples of subspaces  $\mathcal{X} \equiv (\mathcal{X}, \widehat{\varrho}|_{\mathcal{X}})$  of  $(\mathcal{S}'(G), \widehat{\varrho})$  with  $\widehat{\varrho}|_{\mathcal{X}} < \infty$ 

#### Example 3.1.

(1) Suppose G is finitely generated and  $n := \operatorname{rank} G \geq 1$ .

(Proof)

- (i) Since  $S = C_A$  for some  $A \subset G^{\times}$ , it follows that S is symmetric and conjutgation invariant. Hence,  $\nu_S$  is a conjutgation invariant norm on G (cf. Fact 3.2(3), (4)).
- (ii) Since  $G = S^{\infty}$  and  $T = C_B$  for some  $B \subset G^{\times}$  with  $|B| < \infty$ , it follows that  $\nu_S(T) = \nu_S((B^{\pm})^G) = \nu_S(B^{\pm}) = \nu_S(B)$  and  $(\nu_S)_H(T) = \sup \nu_S(T) = \max \nu_S(B) < \infty$ .
  - 4. The maps on the power sets induced from group homomorphisms

Suppose  $f: G \to H$  is a group homomorphism between groups. Let  $K := \operatorname{Ker} f$ . We are interested in the following general problem.

**Problem.** Describe the relation among the metric spaces  $(S''(G)^*, \nu_H^G)$ ,  $(S''(H)^*, \nu_H^H)$  and  $(S''(K)^*, \nu_H^K)$ .

### 4.1. Generalities.

**Notation 4.1.** The group homomorphism  $f: G \to H$  induces the following maps.

  - 1) The map  $f_*: \mathcal{S}''_{nfg}(G)^* \longrightarrow \mathcal{S}''_{nfg}(H)^*$  has a section  $\eta: \mathcal{S}''_{nfg}(H)^* \longrightarrow \mathcal{S}''_{nfg,Q_{m_0}}(G)^*$ .

As expected, we can see that  $\mu = \mu' = \nu_H^{H,K}$ , when G is the direct product of the subgroups H and K.

    - 5. Word metrics in group actions

### 5.1. Word metrics in group actions.

Suppose X is a set, G is a group, e is the identity element of G and  $\eta: X \times G \to X$  is a right group action.

**Notation 5.1.** We use the following notations. Let  $x \in X$ ,  $A \subset X$  and  $a \in G$ ,  $S \subset G$ .

- (1) We have the maps  $\eta_x: G \to xG \subset X: \eta_x(a) = xa$  and  $\eta^a: X \approx X: \eta^a(x) = xa$ .  $\circ$  The map  $\eta_x$  is injective if and only if the action of G on the orbit xG is free.
- $(2) AS := \{xs \mid x \in A, s \in S\} \subset X$

**Fact 5.1.** Let  $S, T, U, S_{\lambda} \subset G$   $(\lambda \in \Lambda)$  and  $x, y \in X, A, B \subset X$ .

- $(1) \ \ (\mathrm{i}) \ \ y \in xS \iff x \in yS^{-1} \qquad (\mathrm{ii}) \ \ y \in xS^n \iff x \in y(S^{-1})^n = y(S^n)^{-1} \quad (n \in \widetilde{\mathbb{Z}}_{\geq 0})$
- (2) (i)  $A \subset B$ ,  $S \subset T \implies AS \subset BT$  (ii) (AS)T = A(ST) (iii)  $A\left(\bigcup_{\lambda \in A} S_{\lambda}\right) = \bigcup_{\lambda \in A} AS_{\lambda}$

$$d_S: X \times X \longrightarrow \widetilde{\mathbb{Z}}_{\geq 0}: \quad d_S(x, y) = \begin{cases} \min\{n \in \mathbb{Z}_{\geq 0} \mid y \in xS^n\} & (y \in xS^{\infty}) \\ \infty & (y \in X - xS^{\infty}) \end{cases}$$

(2) the Hausdorff metric on S(X) induced from  $d_S$ :

$$(d_S)_H : \mathcal{S}(X) \times \mathcal{S}(X) \longrightarrow \widetilde{\mathbb{Z}}_{\geq 0} :$$

$$(d_S)_H(A, A') := \begin{cases} \min\{n \in \mathbb{Z}_{\geq 0} \mid A' \subset AS^{\leq n}\} & (\exists n \in \mathbb{Z}_{\geq 0} \text{ s.t. } A' \subset AS^{\leq n}) \\ \infty & (\text{otherwise}) \end{cases}$$

(i) For  $n \in \mathbb{Z}_{>0}$   $(d_S)_H(A, A') \leq n \iff A' \subset AS^{\leq n}$ 

Fact 5.2. Let  $x, y \in X$ ,  $a \in G$ ,  $S, T \subset G$  and  $n \in \mathbb{Z}_{\geq 0}$ .

- (1)  $d_S \in \mathcal{M}_{as}(X)$ ,  $d_S$  is nondegenerate  $: \widehat{d_S} \in \mathcal{M}(X)$ 
  - (i)  $d_S(x,y) \le n \iff y \in xS^{\le n}$  (ii)  $d_S(x,y) = 0 \iff x = y$
  - (iii)  $B_{d_S}(x,n) := \{ y \in X \mid d_S(x,y) \le n \} = xS^{\le n}$
- (2) (i)  $d_S(x,y) = d_{S^{-1}}(y,x)$  (ii)  $S = S^{-1} \implies d_S \in \mathcal{M}(X)$
- (3) (i)  $d_{S^a}(xa, ya) = d_S(x, y)$  (ii)  $d_S(xa, ya) = d_S(x, y)$  if S is conjugation-invariant.

### Example 5.1.

- (1) In the case  $(X, \eta) = (G, R)$ , where R denotes the action of G on itself by the right translation, for any  $S \subset G$  the metric  $d_S$  is just the word metric defined in Definition 3.2.
- (2) Suppose X = (X, \*) is a set with a binary operation. Consider the group  $G = \operatorname{Aut}(X)$  with the multiplication  $f \cdot g = g \circ f$   $(f, g \in G)$ .
  - (i) The group G has the canonical right action on  $X: x \cdot f = f(x) \ (x \in X, f \in G)$ .
  - (ii) Any subset  $S \subset G$  induces the word metric  $d_S$  on X.

When X = (X, \*) is a quandle, it has the symmetries :

$$\sigma_a \in \operatorname{Aut}(X) \ (a \in X) : \ \sigma_a(x) = x * a \ (x \in X)$$

The group G includes the following subgroups:

$$G > \operatorname{Inn}(X) := \langle \sigma_a \ (a \in X) \rangle > \operatorname{Dis}(X) := \langle \sigma_a \sigma_b^{-1} \ (a, b \in X) \rangle.$$

For example, we can take S as the generating sets of these subgroups.

Fact 5.3. Each  $S \in \mathcal{S}(G)$  induces the word metrics  $d_S \equiv d_S^G \in \mathcal{M}_{as}(G)$  and  $d_S \equiv d_S^X \in \mathcal{M}_{as}(X)$ .

- (1) For  $x \in X$  we have the map  $\eta_x : (G, d_S) \longrightarrow (xG, d_S|)$ .
  - (i)  $\eta_x$  is a 1-Lipschitz map. (ii) If  $\eta_x$  is injective, then  $\eta_x$  is an isometric bijection.
- (2)  $d_S^X \le \nu_H(S, T) d_T^X$   $(S, T \in \mathcal{S}(G))$  (Here, we set  $\infty \cdot 0 = 0$ .)

Recall the bijections  $\mathcal{S}'(G) \approx \mathcal{S}''(G) \approx \widetilde{\mathcal{S}}(G)$  in Notation 3.3 [II](4).

Consider the map  $\varphi: (\mathcal{S}''(G)^*, \widehat{\varrho}) \approx (\widetilde{\mathcal{S}}(G)^*, \widehat{\widehat{\varrho}} = \widehat{\widehat{\varrho}}) \longrightarrow (F(X^2 - \Delta(X), \widetilde{\mathbb{R}}_{\geq 0}), \widehat{\mu}).$   $S \qquad [S] \qquad \log d_S^X|$ 

Here,  $d_S^X| := d_S^X|_{X^2 - \Delta(X)}$ . Suppose X is not a singleton.

# 5.2. Symmetry of $(X, G, \rho)$ .

#### Notation 5.2.

 $X\times G \stackrel{f\times \varphi}{-} Y\times H$ (1) Suppose  $(X, G, \varrho)$  and  $(Y, H, \zeta)$  are right group actions on sets X and Y. An equivariant map  $(f,\varphi):(X,G,\varrho)\longrightarrow (Y,H,\zeta)$  is a pair of a map  $f: X \to Y$  and a group homomorphism  $\varphi: G \to H$ such that  $f(xa) = f(x)\varphi(a) \ (\forall (x,a) \in X \times G).$ 

The composition of equivariant maps and the identity maps are defined as follows.

- (i)  $(g,\psi)(f,\varphi) := (gf,\psi\varphi)$  for  $(X,G,\varrho) \xrightarrow{(f,\varphi)} (Y,H,\zeta) \xrightarrow{(g,\psi)} (Z,I,\eta)$ .

- (2) In the category of right group actions on sets and equivariant maps between them.
  - (i)  $\operatorname{End}(X,G,\varrho) \supset \operatorname{Aut}(X,G,\varrho)$  denote the monoid of endomorphisms and the group of automorphisms of  $(X, G, \varrho)$ .
  - (ii) An equivariant map  $(f,\varphi):(X,G,\varrho)\longrightarrow (Y,H,\zeta)$  is an isomorphism if and only if both fand  $\varphi$  are bijective. In this case  $(f,\varphi)^{-1}=(f^{-1},\varphi^{-1})$ .

Suppose  $(X, G, \varrho)$  is a right group action on a set X, M is a set with a binary operation and  $(f,\varphi): M \ni u \longmapsto (f_u,\varphi_u) \in \operatorname{End}(X,G,\varrho)$  is an anti-homomorphism.

**Notation 5.3.** Let  $u, v \in M$ ,  $x \in X$ ,  $a, b \in G$  and  $S \subset G$ .

- (1)  $\varphi: M \longrightarrow \operatorname{End}(G)$  is an anti-homomorphism.  $\circ (f_{uv}, \varphi_{uv}) = (f_v, \varphi_v)(f_u, \varphi_u) = (f_v f_u, \varphi_v \varphi_u)$
- (2)  $x^u := f_u(x), \ a^u := \varphi_u(a)$ 

  - (i)  $x^{uv} = (x^u)^v$  (ii)  $(xa)^u = x^u a^u$  (iii)  $a^{uv} = (a^u)^v$  (iv)  $(ab)^u = a^u b^u$  (v)  $(a^b)^u = (a^u)^{b^u}$
- (3) (i)  $S^u := \varphi_u(S) = \{a^u \mid a \in S\}$  (ii)  $S \subset G$  is  $\varphi$ -invariant.  $\iff S^u \subset S$  ( $\forall u \in M$ )

Fact 5.4. Let  $A \subset X$ ,  $S, T \subset G$ ,  $u, v \in M$  and  $n \in \mathbb{Z}_{>0}$ .

- (1) (i)  $(A^u)^v = A^{uv}$  (ii)  $(AS)^u = A^uS^u$
- (2) (i)  $(S^{u})^{v} = S^{uv}$  (ii)  $(ST)^{u} = S^{u}T^{u}$  (iii)  $(S^{T})^{u} = (S^{u})^{T^{u}}$  (3) (i)  $(S^{n})^{u} = (S^{u})^{n}$  (ii)  $(S^{\leq n})^{u} = (S^{u})^{\leq n}$  (iii)  $(S^{\infty})^{u} = (S^{u})^{\infty}$

Fact 5.5. Let  $S \in \mathcal{S}(G)$ .

- $(1) \ d_{S^u}^X(x^u, y^u) \le d_S^X(x, y) \quad (\forall x, y \in X, \ u \in M)$
- (2) If S is  $\varphi$ -invariant, then  $d_S^X(x^u, y^u) \leq d_S^X(x, y)$  ( $\forall x, y \in X, u \in M$ ).
- (3) Suppose M is a monoid,  $e \in M$  is the unit element and  $(f, \varphi)$  is an anti-homomorphism of monoids (i.e.,  $(f_e, \varphi_e) = \mathrm{id}$   $(x^e = x, a^e = a)$ ). Let U(M) denote the group of units of M. For  $u \in U(M)$ the following holds.
  - (i)  $d_{Su}^X(x^u, y^u) = d_S^X(x, y)$  ( $\forall x, y \in X$ )

(ii) If S is  $\varphi$ -invariant, then  $S^u = S$  and  $d_S^X(x^u, y^u) = d_S^X(x, y) \ (\forall x, y \in X)$ .

### Example 5.2.

- (1) Suppose M is a \*-subset of  $\operatorname{End}(X,G,\varrho)$  (i.e., M is closed under the multiplication). We reverse the multiplication of M so that the inclusion  $M \subset \operatorname{End}(X,G,\varrho)$  is an anti-homomorphism.
  - (i) M acts on X and G by  $x^{(f,\varphi)} = f(x)$  and  $a^{(f,\varphi)} = \varphi(a)$   $(x \in X, a \in G, (f,\varphi) \in M)$ .
  - (ii) If  $S \subset G$  is M-invariant (i.e.,  $S^{(f,\varphi)} = \varphi(S) \subset S$  ( $\forall (f,\varphi) \in M$ )), then  $d_S^X(f(x), f(y)) \leq d_S^X(x, y)$  ( $\forall x, y \in X, (f,\varphi) \in M$ ).
- (2) When  $M \subset \operatorname{Aut}(X, G, \varrho)$  is a subgroup under the reverse multiplication,
  - (i)  $d_{\varphi(S)}^X(f(x), f(y)) = d_S^X(x, y) \quad (\forall x, y \in X, (f, \varphi) \in M)$
  - (ii) If  $S \subset G$  is M-invariant, then  $\varphi(S) = S$  and  $d_S^X(f(x), f(y)) = d_S^X(x, y) \quad (\forall x, y \in X, \ (f, \varphi) \in M).$

**Example 5.3.** Each action  $(X, G, \varrho)$  admits a canonical anti-homomorphism

$$(f,\varphi): G \longrightarrow \operatorname{Aut}(X,G,\varrho): (f_a,\varphi_a) = (\varrho_a,a^{-1}()a).$$

However, this symmetry yields no new information, as seen below.

- (1) Let  $x \in X$ ,  $a, g \in G$  and  $S \subset G$ .
  - (i)  $x^a = \varrho_a(x) = xa$ ,  $g^a = \varphi_a(g) = a^{-1}ga = g^a$  (in the sense of Section 3)
  - (ii)  $S^a = \varphi_a(S) = a^{-1}Sa = S^a$  (in the sense of Section 3)
  - (iii) S is  $\varphi$ -invariant.  $\iff a^{-1}Sa \subset S \ (\forall a \in G) \iff S$  is conjugation invariant.
- (2) Fact 5.5(3) implies the following statements, which exactly restate Fact 5.2(3).
  - $(\mathrm{i}) \quad d^X_{S^a}(xa,ya) = d^X_S(x,y) \quad (^\forall x,y \in X, \ ^\forall a \in G).$
  - (ii) If S is conjugation invariant, then  $d_S^X(xa,ya) = d_S^X(x,y)$   $(\forall x,y \in X, \ \forall a \in G)$ .
- (3) If we consider the action of a group G on itself by the right translation

$$(G,G,R): R:G \curvearrowleft G:R(x,a)=xa$$

and the anti group homomorphism

$$(f,\varphi): G \longrightarrow \operatorname{Aut}(G,G,R): (f_a,\varphi_a) = (R_a,a^{-1}()a),$$

then we recover the statements in Fact 3.2.

### 6. Word length on \*-sets

#### 6.1. \*-sets.

In this section we extend the arguments for groups in the previous sections to the case of sets with binary operations.

**Definition 6.1.** A \*-set means a set X with binary operations  $*_i: X \times X \to X \ (i = 1, \dots, m)$ .

Let  $X = (X, (*_i)_{i \in [m]})$  be a nonempty \*-set.

#### Notation 6.1.

- (1) A \*-subset of X means a subset  $Y \subset X$  such that  $y_1 *_i y_2 \in Y$  ( $\forall i \in [m]$ ) for any  $y_1, y_2 \in Y$ .
  - (i) In the case of unital \*-sets (i.e., \*-sets with an identity element), we can consider unital \*-subsets.
- (2)  $S_*(X) := \text{the set of } *\text{-subsets of } X$

- (i)  $S_*(X)$  is closed under intersection (i.e.,  $Y_{\lambda} \in S_*(X)$   $(\lambda \in \Lambda) \implies \bigcap_{\lambda \in \Lambda} Y_{\lambda} \in S_*(X)$ ).
- (3) Let  $x, y, x_1, \dots, x_n \in X$ .
  - (i) The symbol x \* y denotes any of  $x *_i y$   $(i \in [m])$ .
  - (ii) The symbol  $x_1 * \cdots * x_n$  denotes any product of  $x_1, \cdots, x_n$  in this order under the (mixed) operations  $*_i (i \in [m])$  and suitable ()'s.

$$\circ \mathcal{S}_*(X) \ni Y \ni x_1, \cdots, x_n \ (n \in \mathbb{Z}_{>1}) \implies x_1 * \cdots * x_n \in Y$$

(4) 
$$A * B := \{a * b \mid a \in A, b \in B\} \equiv \{a *_i b \mid a \in A, b \in B, i \in [m]\}$$
  $(A, B \subset X)$   
 $A_1 * \cdots * A_n := \{a_1 * \cdots * a_n \mid a_i \in A_i \ (i \in [n])\}$   $(n \in \mathbb{Z}_{>1}, A_1, \cdots, A_n \subset X)$ 

### Notation 6.2. Let $S \subset X$ .

- (1) The \*-subset of X generated by S means the smallest \*-subset of X including S. It exists and is obtained formally by  $\langle S \rangle := \bigcap \{ Y \in \mathcal{S}_*(X) \mid S \subset Y \}.$
- (2) The \*-subset  $\langle S \rangle$  has the following explicit description:  $\langle S \rangle = S^{\infty}$

(i) 
$$S^n := \underbrace{S * \cdots * S}_n \equiv \{x_1 * \cdots * x_n \mid x_i \in S \ (i \in [n])\} \quad (n \in \mathbb{Z}_{\geq 1})$$

• Inductive definition:

$$S^{1} = S S^{k} (k \in [n]) \Rightarrow S^{n+1} = \bigcup \{S^{k} * S^{\ell} \mid k, \ell \in \mathbb{Z}_{\geq 1}, k + \ell = n + 1\}$$
  
 
$$\circ S^{2} = S * S, S^{3} = (S^{1} * S^{2}) \cup (S^{2} * S^{1}) = (S * (S * S)) \cup ((S * S) * S), \text{etc.}$$

- (ii)  $S^{\leq n} := \bigcup_{k \in [n]} S^k$   $(n \in \mathbb{Z}_{\geq 1})$   $S^{\infty} := \bigcup_{n \in \mathbb{Z}_{\geq 1}} S^n$
- (iii) In the unital case (i.e., X has the identity element e), we set  $S^0 := \{e\}$  and  $S^\infty := \bigcup_{n \in \mathbb{Z}_{\geq 0}} S^n$ .

#### Fact 6.1.

- (1) (i)  $S^k * S^\ell \subset S^{k+\ell}$   $(k, \ell \in \mathbb{Z}_{\geq 1})$ • This implies that  $S^{\infty} \in \mathcal{S}_*(X)$  and  $\langle S \rangle = S^{\infty}$ .
  - (ii)  $S^{\leq k} * S^{\leq \ell} \subset S^{\leq k+\ell} \quad (k, \ell \in \mathbb{Z}_{\geq 1})$
- (2) (i)  $(S^k)^{\ell} \subset S^{k\ell}$  (ii)  $(S^{\leq k})^{\leq \ell} \subset S^{\leq k\ell}$   $(k, \ell \in \mathbb{Z}_{\geq 1})$

# 6.2. Word length on a \*-set.

**Definition 6.2.** (Word length) Let  $S \subset X$ .

(1) 
$$\nu_S: X \longrightarrow \widetilde{\mathbb{Z}}_{\geq 1}: \quad \nu_S(x) = \begin{cases} \min\{n \in \mathbb{Z}_{\geq 1} \mid x \in S^n\} & (x \in S^\infty) \\ \infty & (x \in G - S^\infty) \end{cases}$$

(i) In the unital case  $\mathbb{Z}_{>1}$  is replaced by  $\mathbb{Z}_{>0}$ .

### Fact 6.2.

- (1) (i)  $\nu_S(x) \le n \iff x \in S^{\le n} \quad (x \in X, n \in \mathbb{Z}_{>1})$ 
  - (ii)  $\nu_S^{-1}(1) = S$   $(\nu_S^{-1}(1) = S \{e\} \text{ in the unital case})$
- (2) (i)  $\nu_S(x * y) \le \nu_S(x) + \nu_S(y)$   $(x, y \in X)$ 
  - (ii)  $\nu_S(x_1 * \cdots * x_n) \le \nu_S(x_1) + \cdots + \nu_S(x_n)$   $(x_i \in X \ (i \in [n]))$   $(n \in \mathbb{Z}_{>1})$

**Definition 6.3.** (the induced metric on  $S(X)^{\times} = S(X) - \{\emptyset\}$ )

(1) 
$$\nu_H : \mathcal{S}(X)^{\times} \times \mathcal{S}(X)^{\times} \longrightarrow \widetilde{\mathbb{Z}}_{>1} : \ \nu_H(S, S') = \sup \nu_S(S')$$

(2) 
$$\varrho := \log \nu_H : \mathcal{S}(X)^{\times} \times \mathcal{S}(X)^{\times} \longrightarrow \log \widetilde{\mathbb{Z}}_{>1} \subset \widetilde{\mathbb{R}}_{>0}$$

### Fact 6.3.

(1) 
$$\nu_H(S, S') \le n \iff S' \subset S^{\le n} \quad (S, S' \in \mathcal{S}(X)^{\times}, n \in \mathbb{Z}_{\ge 1})$$

(2)  $\nu_H \in \mathcal{M}_{m,as}(\mathcal{S}(X)^{\times}), \quad \nu_H \text{ is nondegenerate.}$ 

(i) 
$$\nu_H(S, S') = 1 \iff S' \subset S$$
 (i)  $\nu_H(S, S') = \nu_H(S', S) = 1 \iff S = S'$ 

(ii) 
$$\nu_H(S, S'') \le \nu_H(S, S')\nu_H(S', S'')$$
  $(S, S', S'' \in \mathcal{S}(X)^{\times})$ 

(3) 
$$\varrho \in \mathcal{M}_{as}(\mathcal{S}(X)^{\times}), \quad \varrho \text{ is nondegenerate.} \qquad \therefore \widehat{\varrho} \in \mathcal{M}(\mathcal{S}(X)^{\times})$$

**Example 6.1.** Some examples of subspaces  $\mathcal{X} \subset \mathcal{S}(X)^{\times}$  with  $\widehat{\varrho}|_{\mathcal{X}} < \infty$ 

Let 
$$S_q(X) := \{ S \in S(X) \mid X = S^{\infty} \} \subset S(X)^{\times}.$$

$$(1) \mathcal{S}_{fg}(X) := \{ S \in \mathcal{S}_g(X) \mid |S| < \infty \}$$

(2) 
$$S_g(X; \text{ finite rel } S_0) := \{ S \in S_g(X) \mid |S - S_0| < \infty, |S_0 - S| < \infty \}$$
  $(S_0 \in S_g(X))$ 

(i) If 
$$S \in \mathcal{S}_q(X)^{\times}$$
,  $S' \in \mathcal{S}(X)^{\times}$  and  $|S' - S| < \infty$ , then  $\nu_H(S, S') < \infty$ 

For word metrics on the \*-set X we have the following candidates.

**Notation 6.3.** (Word metrics) Let  $S \subset X$ .

$$d_S: X \times X \longrightarrow \widetilde{\mathbb{Z}}_{\geq 0}: d_S(x, y) = \begin{cases} \min\{n \in \mathbb{Z}_{\geq 0} \mid y \in [x, S, n]\} & (y \in \bigcup_{n \in \mathbb{Z}_{\geq 0}} [x, S, n]) \\ \infty & (\text{otherwise}) \end{cases}$$

Here, we can take the family [x, S, n]  $(x \in X, n \in \mathbb{Z}_{\geq 0})$  as follows:

$$(1) \ [x,S,n] := x * \underbrace{S * \cdots * S}_{n} \quad (n \in \mathbb{Z}_{\geq 1}) \qquad [x,S,0] := \{x\} \qquad \circ \ [x,S,n] \ \supset \ x * (S^{n})$$

(2) 
$$[x, S, n]' := ((\cdots ((x * \underbrace{S) * S) * \cdots * S) * \underbrace{S}}_{n} \quad (n \in \mathbb{Z}_{\geq 1})$$
  $[x, S, 0]' := \{x\}$ 

We denote by  $d_S'$  the metric  $d_S$  defined in the case (2).

Fact 6.4.  $d_S, d'_S \in \mathcal{M}_{as}(X)$  and they are nondegenerate.  $\widehat{d_S}, \widehat{d'_S} \in \mathcal{M}(X)$ .

(1) (i) 
$$d_S(x,y) = 0 \iff x = y$$
 (ii)  $d_S(x,z) \le d_S(x,y) + d_S(y,z)$  ( $\forall x, y, z \in X$ )

$$(2) \quad \text{(i)} \quad d_S'(x,y) = 0 \iff x = y \qquad \text{(ii)} \quad d_S(x,z) \leq d_S(x,y) + d_S(y,z) \qquad (\forall x,y,z \in X)$$

6.3. Symmetry of a \*-set.

Let X be a \*-set.

#### Notation 6.4.

(1) A map  $f: X \to X$  is said to be a \*-endomorphism if  $f(x *_i y) = f(x) *_i f(y) (x, y \in X, i \in [m])$ .  $\circ$  In this case, (i)  $S \in \mathcal{S}_*(X) \implies f(S) \in \mathcal{S}_*(Y)$  (ii)  $R \in \mathcal{S}_*(Y) \implies f^{-1}(R) \in \mathcal{S}_*(X)$ 

(2)  $\operatorname{End}(X)$  denotes the monoid of \*-endmorphisms of X

Suppose  $(R, \star)$  is a nonempty set with a binary operation and  $\varphi : R \longrightarrow \operatorname{End}(X)$  is an anti-homomorphism.

#### Notation 6.5.

(1) 
$$x^a := \varphi(a)(x) \in X \quad (x \in X, a \in R)$$
 (2)  $S^A := \{x^a \mid x \in S, a \in A\} \quad (S \subset X, A \subset R)$ 

(2) 
$$S \subset X$$
 is  $\varphi$ -invariant  $\stackrel{\mathrm{def}}{\Longleftrightarrow} S^a \subset S \quad (\forall a \in R) \iff S^R \subset S$ 

Fact 6.5. Let  $x, y \in X$ ,  $S \subset X$ ,  $a, b \in R$  and  $A, B \subset R$ .

$$(1) \ \ (\mathbf{i}) \ \ (x*y)^a = x^a*y^a \ \ \ (\mathbf{ii}) \ \ (x^a)^b = x^{a\star b} \ \ \ (\mathbf{iii}) \ \ (S^A)^B = S^{A\star B} \ \ \ (\mathbf{iv}) \ \ (S \cup T)^A = S^A \cup T^A$$

(2) (i) 
$$(Y*Z)^a = Y^a*Z^a$$
  $(Y,Z\subset X)$  (ii)  $(\bigcup_{\lambda\in\Lambda}Y_\lambda)^a = \bigcup_{\lambda\in\Lambda}Y_\lambda^a$   $(Y_\lambda\subset X\ (\lambda\in\Lambda))$ 

- (3) (i)  $(x_1 * \cdots * x_n)^a = x_1^a * \cdots * x_n^a$   $(x_i \in X \ (i \in [n]))$  (The products are taken in the same form in the left side and right side.)
  - (ii)  $(S^n)^a = (S^a)^n$   $(n \in \mathbb{Z}_{>1})$   $(S^\infty)^a = (S^a)^\infty$   $\langle S \rangle^a = \langle S^a \rangle$
- (4) (i)  $S^R$  is  $\varphi$ -invariant. (ii)  $(S \cup S^R)^R = S^R \subset S \cup S^R$   $\therefore S \cup S^R$  is  $\varphi$ -invariant.
  - (ii) S is  $\varphi$ -invariant.  $\Longrightarrow$   $(S^n)^a \subset S^n$   $(n \in \mathbb{Z}_{>1}), (S^\infty)^a \subset S^\infty$

Fact 6.6. Suppose  $S \in \mathcal{S}(X)^{\times}$  is  $\varphi$ -invariant.

- $(1) \ \nu_S(x^a) \le \nu_S(x) \quad (\forall x \in X, \forall a \in R)$
- (2)  $\nu_H(S, T^R) \le \nu_H(S, T \cup T^R) = \nu_H(S, T) \quad (\forall T \in \mathcal{S}(X)^{\times})$

**Example 6.2.** Further examples of subspaces  $\mathcal{X} \subset \mathcal{S}(X)^{\times}$  with  $\widehat{\varrho}|_{\mathcal{X}} < \infty$ 

- (1)  $S_{\varphi fg}(X) := \{ S \in S_g(X) \mid S = F^R \text{ or } F \cup F^R \ (\exists F \in S_f(X)^{\times}) \}$ 
  - $\circ$  For any  $S, T \in \mathcal{S}_{\varphi fq}(X)$
  - (i)  $S \in \mathcal{S}_q(X)$ , S is  $\varphi$ -invariant. (ii)  $T = F^R$  or  $F \cup F^R$  for some  $F \in \mathcal{S}_f(X)^{\times}$ .
  - (iii)  $\nu_H(S, F^R) \le \nu_H(S, F \cup F^R) = \nu_H(S, F) < \infty$   $\therefore \nu_H(S, T) < \infty$
- (2)  $S_{\varphi q}(X; \text{ finite rel } F_0) := \{ S \in S_q(X) \mid S = F^R \text{ or } F \cup F^R \ (\exists F \in S(X, \text{ finite rel } F_0)^{\times} \}$ 
  - $\circ \ \mathcal{S}(X; \text{ finite rel } F_0)^{\times} := \{ F \in \mathcal{S}(X)^{\times} \mid |F F_0| < \infty, |F_0 F| < \infty \}$   $(F_0 \in \mathcal{S}(X)^{\times})$
  - For any  $S, T \in \mathcal{S}_{\varphi q}(X; \text{ finite rel } F_0)$
  - (i)  $S \in \mathcal{S}_q(X)$ , S is  $\varphi$ -invariant. (ii)  $S = F \cup F^R$  for some  $F \in \mathcal{S}(X)$ , finite rel  $F_0$ .
  - (iii)  $T = G \cup G^R$  for some  $G \in \mathcal{S}(X, \text{ finite rel } F_0)^{\times}$ .
  - (iv)  $G S \subset G F \subset (G F_0) \cup (F_0 F) \in \mathcal{S}_f(X)$ 
    - $\therefore \nu_H(S,G) < \infty$  (cf. Example 6.1 (2)(i))
  - $(\mathbf{v}) \ \nu_H(S,G^R) \leq \nu_H(S,G \cup G^R) = \nu_H(S,G) < \infty \quad \therefore \ \nu_H(S,T) < \infty$
